

Annual General Meeting Minutes 2020-12-01

- **1.** The Zoom meeting was called to order by President Judy Stirling at 4:10pm. 52 LBC members and 3 visitors were registered with 39 in attendance.
- 2. Welcoming Remarks: Judy Stirling
- 3. Approval of the Agenda
- **4. Motion to Accept the Minutes** for the AGM on September 21, 2019. Motion by Sue Edwards, seconded by Mary Howe. Motion carried.
- 5. President's Report: Judy Stirling
 - * LBC is now 5 years old with 456 members
 - * ACBL ranks LBC in the top 100 out of 2724 clubs
 - * We are the 12th largest club in Canada
 - * Our table count had increased over previous years (prior to COVID)
 - * LBC joined with BBO in late March to provide both open and limitedpoint games online which provide both income for the club and comradery with our fellow members. There are now 6 virtual games per week.
 - * Our library is growing and a thank you goes out to Roger and Judy Jolliffe
 - * ACBL Live has been added by Bruce
 - * An IMP league was started by Dwight with great success
 - * A new larger tv monitor has been added as well as headsets in theteaching room and an equipment upgrade to the sound system
 - * Prior to COVID, Bridge education was active with Patti Lee seminar, several courses, Saturday & Tuesday practice and play and 5th chair. Since COVID there has been 1 online course and several 5th chair games.

6. Financial Report: Tom Jolliffe

The Financial statements are posted on the website. Tom explained that Game Fees were down by \$46,000, offset by \$25,000 in BBO Commissions, \$11,000 reduction in director fees and \$13,000 reduction in rent. Net income was \$8,835.

Tom Jolliffe opened the meeting for questions regarding the Financial Report

- 6.1 Question: (email) Does the club show restricted donations separately on the Balance Sheet? Answer: (Tom) At this time, there are no such donations, but this could be something for discussion at a Board meeting.
- 6.2 Question: (John Stoffman) Should game directors be receiving payment for the time spent directing games instead of probono? Answer: (Tom) This has been discussed at length at the Board meetings and may change in the future.
- 6.3 Question: (Marie Wiley) Will we need to pay back shortfall money to the landlord? Answer: (Tom & AI) This was a government program whereby the waived money is not required to be paid back. As well there is a new program in place which offers similar rent subsidies.
- 6.4 Question: (Ann Lapchinski) How is the BBO commission divided between the other participating clubs ie, St Thomas, Tillsonburg etc? Answer: (Al) The commission for all virtual games that LBC hosts stays with LBC. The commission for Support your Club games is divided among the clubs where players played in 2019 and 2020.
- 6.5 Question: (Barb O'Brien) When are dues needed to be paid? Answer: (Al) No plans yet. Possibly when the club re-opens.

Motion to accept the Financial Statements for the year ending July 31st, 2020 by Tom Jolliffe. Seconded by Marie Wiley....carried.

Motion that Gary Westfall be appointed as auditor to review the financial statements ending July 31st, 2021 by Tom Jolliffe. Seconded by Mary Howe. .. carried.
